

MyRepublic GAMER Arena Tournament Terms & Conditions

MyRepublic GAMER Arena Tournament ("GAMER Arena") is organised by MyRepublic Limited ("MyRepublic"). By registering and therefore participating in GAMER Arena, you, the participant, agree to be bound by GAMER Arena Tournament Terms & Conditions and the respective tournament rules (collectively, the "Terms").

The decision of the MyRepublic will be deemed as final and irrefutable, and no correspondence will be entered into about GAMER Arena.

1. Tournament Period

- 1.1. The tournaments are on dates stated below (the "Tournament Dates"). Registration for Season 1 Matches will start on 30 November 2018 at 12.00am Singapore time, and ends 1 March 2019 at 11.59pm Singapore time. Any entries received thereafter will not be eligible for consideration. "Match" means the online game match.

1.3. Tournament Dates may change as a result of unforeseeable circumstances and you will be notified through the GAMER Arena website.

2. GAMER Arena Entry

- 2.1. GAMER Arena is open to all Singapore citizens and permanent residents of the Republic of Singapore residing in Singapore during Tournament Date. Employees (and members of their immediate families) of MyRepublic Limited are prohibited from participating in GAMER Arena.
- 2.2. You must be at least 18 years of age based on the year of birth at the time of participation.
- 2.3. You must only enter the competition in your own name. Registration for GAMER Arena is non-transferable nor refundable.
- 2.4. Only one entry per participant is accepted.
- 2.5. All information submitted must be accurate and complete and are subject to proof upon request by MyRepublic. MyRepublic reserves the right, at any time, to verify your entry and to disqualify

- any entry not submitted in accordance with these Terms. Any misrepresentation of any fact or information may requite in forfeiture, withholding, withdrawal or reclaiming of any prizes won.
- 2.6. Only fully completed comprehensible GAMER Arena entries or registration will be accepted by MyRepublic for participation. MyRepublic has the sole and absolute discretion to determine your eligibility.
- 2.7. MyRepublic is not responsible for any loss of entries due to any problems caused by telephone lines or systems or internet service providers, for entries received after the deadline as a consequence of telephone or internet service delays, interruptions, failures or overloads. Entries are void if unreadable, inaccurate, incomplete, damaged, mutilated, tampered with, falsified, mechanically reproduced, irregular in any way or otherwise not in compliance with these Terms.
- 2.8. MyRepublic reserves the right to edit your nicknames and/or URL aliases, if you use nicknames and/or URL aliases that:
 - (a) resemble or identical to a brand, trademark or well-known clan, no matter whether it has been registered or not;
 - (b) are against public morals and conventions;
 - (c) commercial in nature, such as use of product or brand names;
 - (d) resemble or if they are identical to a real person other than yourself; or
 - (e) are non-legible or readable, has alternative spelling, gibberish or inaccurate spelling

3. GAMER Arena Tournament Format

- 3.1. Tournaments are based on a single or double elimination Match format.
- 3.2. You must be available on the Match dates. No substitution of participant(s) is permitted.
- 3.3. Official communication channel during the Matches is "Discord". All communications must be in English. Use of any other languages during a Match may lead to disqualification.
- 3.4. Bracket shuffle will be done after registration is closed. Team captains will be notified through email and text ("SMS") provided by them on their respective entries. Texts received by team captains may be charged at the team captain's mobile network provider operator charge.
- 3.5. Each team is required to join the Official MyRepublic GAMER Arena Discord ("Discord") for reporting 15 minutes prior to every Match. A 10-minute grace from the start time of the Match is given to late participants. A win will be awarded to the other team if the full team is unable to check in 10 minutes after start time.
- 3.6. The Match will only start when the full team checks in.
- 3.7. Your name and game ID name will be checked by MyRepublic offline prior to commencement of semi-finals and final Matches.

4. Participant Conduct

- 4.1. At all times while participating in GAMER Arena, you must not:
 - (a) post, or transmit through GAMER Arena any content that is defamatory, abusive, vulgar, obscene, profane or offensive:
 - (b) infringes or violates another party's intellectual property rights;
 - (c) violates any party's right to protection of personal data;
 - (d) threatens, harasses or that promotes racism, bigotry, hatred or physical harm of any kind against any group or individual;
 - (e) promotes or encourages violence;
 - (f) illegal or promotes any illegal activities;
 - (g) participate in betting on Matches;
 - (h) engage in, or in connection with fraudulent activity;

- (i) participate in any action which tends to shock, insult or offend the community or public morals or decency or damage the Organisers or tournament reputation; or
- (j) contains any advertising, promotional materials, "junk mail," "spam," "chain letters," "pyramid schemes," or any other form of solicitation
- 4.2. For clarity, Clause 4.1 above applies to registration of nicknames and/or URL aliases.
- 4.3. Hacks, mods, cheats or third party applications are not allowed. Any form of cheating including without limitation sharing accounts, ghosting and piloting, is strictly prohibited. Any form of cheat may result in penalties or total disqualification, solely determined at MyRepublic's discretion.

4.4. You must not:

- (a) gain unauthorized access to the GAMER Arena's systems or any account (other than the participant's own), interfere with the communications, procedures or performance of GAMER Arena or deliberately damage or undermine any systems or sites related to GAMER Arena:
- (b) affect the outcome of any participant's Match means of or with the assistance of macros, bots, automated programs, screen analysis utilities, player collusion, any type of game modifications, script modification, memory readers, telepathy, alien technology or similar methods or to otherwise commit fraud in relation to GAMER Arena;
- (c) use a programme that provides an advantage in a Match;
- (d) alter a game through any means, including without limitation use of custom data;
- (e) alter the human skill component of any game played in the tournament; or
- (f) not data scrape, copy, aggregate, redistribute, alter, reproduce or re-use for commercial purposes any participant's information accessible through GAMER Arena
- 4.5. Any attempt to carry out acts in Clauses 4.1 to 4.4 above will result in the termination of participation and forfeiture of any prize to which you would otherwise receive. MyRepublic, in its sole discretion, reserves the right to terminate your entry if you are suspected of tampering with Match game results.
- 4.6. MyRepublic shall have the right, but not the obligation, to monitor the content of the tournaments, including chats, to determine compliance with these Terms and any rules established by MyRepublic and to satisfy any law, regulation or authorized government request.

5. Prizes

- 5.1. The prize is as specified in the respective tournament rules. The process for determining the winner of the prize is as indicated in the tournament rules.
- 5.2. Claims for prizes must be made in Singapore, in the manner and within the time specified on the respective tournament rules. Failure to claim a prize within one (1) month or in the manner specified may result in disqualification and selection of an alternate winner. MyRepublic will not deliver any prizes to winners located outside of Singapore.
- 5.3. The prize may be in the form of cash or physical goods. For clarity, any physical goods awarded is non-refundable and no cash alternative will be given. MyRepublic reserves the right to substitute prizes of equal or greater value at any time.
- 5.4. MyRepublic reserves the right to deal with any unclaimed prize in any manner it deems fit.
- 5.5. MyRepublic's decision on all matters relating to GAMER Arena Tournaments will be final, binding and conclusive on all participants participating in GAMER Arena, and no correspondence will be entertained. Where applicable, you may be subject to such further terms as specified by MyRepublic and agrees to abide by the same.

6. Data Protection and Publicity

- 6.1. You understand that participation in GAMER Arena may require you to directly provide information which may personally identify you ("personal data") to third party game service providers to access a Match.
- 6.2. MyRepublic will not disclose your personal data to a third party without your consent. Please refer to MyRepublic's Privacy Policy for further details.
- 6.3. As part of GAMER Arena, you may have the ability to include certain personal data in your public profile and by doing so, you hereby consent to the public disclosure of your personal data provided on your public profile.
- 6.4. By participating in GAMER Arena, you hereby consent and grant to MyRepublic a perpetual, non-exclusive, royalty-free license to use, reproduce, edit, modify, create derivatives works from, combine with other works, post, transmit, display, publish, communicate to public, broadcast, distribute and/or otherwise visually exploit your Match data (if applicable), your name, Instagram photo, written communications, likeness and any other details supplied as part of GAMER Arena in any media, technology or content delivery mechanism now known or hereinafter devised for GAMER Arena, in connection of promotional and marketing purposes of MyRepublic, without requiring any further consent or additional consideration.

7. General Terms

- 7.1. You are responsible for obtaining and maintaining all equipment needed for your access to, use of GAMER Arena and all charges related thereto. MyRepublic shall not be liable for damage to your equipment in any way including without limitation any server failure, lost, delayed or corrupted data or other malfunction.
 - 7.2. You agree that GAMER Arena are provided on an "as is" and "as available" basis. MyRepublic is not responsible for technical, hardware or software malfunctions, failure to store your Match data, your in-game communication data or personalised settings, lost or unavailable network connections, disconnection from your Match, interruptions or any incorrect or inaccurate results that may be posted regarding your Match. These Matches may be suspended temporarily and without notice in the case of system failure, maintenance or repair or for reasons reasonably beyond the control of MyRepublic.
 - 7.3. MyRepublic makes no representation, warranty or guarantee, expressed or implied, in fact or law, relative to any prize, including but not limited to its quality, mechanical condition, fitness for any purpose or non-infringement.
 - 7.4. To the maximum extent permitted by law, you agree to indemnify each of the MyRepublic, sponsors, licensors and third party content providers ("Organisers") from any losses, damages, costs, expenses, claims or liabilities of any kind arising in connection with your participation in GAMER Arena.
 - 7.5. To the maximum extent permitted by law, you agree that Organisers shall not be liable for loss, claims or damage of any kind arising out of or in connection with execution of GAMER Arena, your acts omissions or negligence, awarding, use, misuse or possession of the awarded prize. In the event the limitation of liability is not permitted by law, MyRepublic's aggregate cumulative liability shall not exceed S\$30 whether in contract or tort (including negligence) or otherwise resulting or arising from or connected with GAMER Arena or these Terms.
 - 7.6. MyRepublic may terminate GAMER Arena, vary Tournament Dates or vary these Terms without prior notice at its sole and absolute discretion. Any changes will be posted within the Terms. Such modifications shall be immediately effective and apply to all entries, including entries that have been submitted to MyRepublic.
 - 7.7. MyRepublic reserves the right to disqualify you if it has reasonable grounds to believe you have breached any of the Terms.

- 7.8. In the event of any inconsistency between these Terms and any brochure, marketing or promotion material relating to GAMER Arena, these Terms shall prevail.
- 7.9. GAMER Arena shall be governed by Singapore law and you agree to submit any claim, dispute or controversy to the exclusive jurisdiction of the courts of the Republic of Singapore.
